Ordinance

1. This Ordinance may be cited as the Postgraduate Institute of Agriculture (Amendment) Ordinance, No. 9 of 1996 and shall come into force upon its publication in the *Gazette*.
2. The Postgraduate Institute of Agriculture Ordinance, No. 9 of 1979 published in *Gazette Extraordinary* No. 68/11 of 26th December, 1979, is hereby amended by the insertion immediately after Sub-paragraph (1) of paragraph 7 thereof, of the following proviso:-

"Provided, however that, no person shall be appointed as Director of the Institute for more than two consecutive terms."
