BY virtue of the powers vested in me by Sub-section (1) of Section 27 of the Universities Act, No. 16 of 1978, I, Prof. Watareke Arachchilage Wiswa Warnapala, Minister of Higher Education, do by this Order, amend the order made under Section 21 of the aforesaid Act, on the recommendation of the University Grants Commission, and published in *Gazette Extraordinary* No. 896/2 of November 07, 1995, in relation to the Sabaragamuwa University of Sri Lanka, as amended

from time to time, by the repeal of Paragraphs (iv) and (v) of such Order along with all the entries contained in Column I and Column II of the Schedule to such Order, and the Substituted therein for of the following :-

“(iv) assign to such University the following Faculties :-

(v) specify that each Faculty of such University, assigned to the University under paragraph (iv) and specified in Column I of the Schedule set out below, shall comprise the Departments of Study as are specified in the corresponding entries to each such Faculty in Column II.
