## PAYMENTS FOR CONDUCTING DISCIPLINARY INQUIRIES

Your attention is drawn to the Establishments Circular Letter No. 06/2006 of 06.03.2006.

The Department of Management Services by their letter of DMS/0008/OUSL dated 30.09.2014 has informed to apply the rates specified below when making payments for conducting disciplinary inquiries by Higher Educational Institutions with effect from 30.09.2014.

In addition to the payments stipulated above Public Officers currently in service based on his/her post and retired Disciplinary Inquiry Officers based on the post held by him/her at the time of retirement are entitled for travelling allowances and combined allowances. Public Officers who have served in Public Corporations and Statutory Boards are entitled for

travelling allowances and combined allowances based on the post held by him/her at the time of retirement as per the provisions laid down by Department of Management Services Circular No. 34.

The other provisions of the Establishments Circular Letter No. 06/2006 will remain unchanged.
