## AMENDMENT TO THE SELECTION COMMITTEE FOR THE POST OF BURSAR

Your reference is drawn to composition of the Selection Committee for the post of Bursar laid down in para.12 of Commission Circular No. 166 of 06.04.1982 and para 12 of Appendix III of the Establishments Code of the UGC & the Higher Educational Institutions on Procedure for Appointment.

- O2. The University Grants Commission having considered a clarification sought with regard to conducting of a Selection Committee for the post of Bursar in the absence of Registrar of the University, decided to amend the composition of Selection Committee for the post of Bursar at sub-para. (c), as follows;
  - a) The principal executive officer, who shall be the Chairman
  - b) One member appointed by the Commission
  - c) The Registrar of the University or the Open University or the Secretary of the University College, as the case may be;
    - In the absence of the permanent Registrar of the University or where an officer, not holding the post of Registrar, is acting in the post/attending to the duties of the office of Registrar, the University Grants Commission shall appoint a Registrar from another University.
  - d) Two members appointed by the governing authority, of whom one shall be a senior public officer;

Provided that at least one of members so appointed shall be a member of the Institute of Chartered Accountants of Sri Lanka or of the Institute of Cost and Management Accountants or of the Association of Certified and Corporate Accountants.
