PAYMENT OF INCREMENTS IN RECOGNITION OF EDUCATIONAL / PROFESSIONAL QUALIFICATIONS TO THE NON-ACADEMIC NON-ADMINISTRATIVE STAFF.

Your kind attention is invited to the Commission Circular No. 490 dated 30/09/1991 and subsequent Commission Circulars and letter No. UGC/HR/2/3/114 dated 10/09/2005 issued from time to time in respect of granting increments for the staff in the Non-Academic Non-Administrative grades in recognition of the educational / professional qualifications.

- 2. The University Grants Commission at its 951st & 953rd meetings held on 20/10/2016 and 17/11/2016 respectively decided to revise the method of payment in respect of the above, as follows;
 - i. To grant four (04) increments to the employees in the Non-Academic Non-Administrative grades in recognition of any degree/professional qualification comparable to a degree offered by a recognized university in Sri Lanka and a foreign degree offered by recognized university as given in Commonwealth Universities Year Book or International Handbook of Universities.
 - ii. To grant two (02) increments to the employees in the Non-Academic Non-Administrative grades in recognition of a diploma course which should be at Sri Lanka Qualification Framework (SLQF) Level 3 or 4 (Diploma or Higher Diploma) offered by a recognized institution.
- 3. However, the above increments are paid provided that they have not been recruited / promoted on the basis of such qualification in terms of the relevant approved Schemes of Recruitment.
- 4. The Commission further decided that,
 - i. An employee is entitled to receive increments on this basis either for one degree / professional qualification equivalent to a degree or one diploma/professional qualification equivalent to a diploma course.
 - ii. The employees who have been receiving more than 3 increments as at 01st May 2016 as per the provisions of letter No. UGC/HR/2/3/114 dated 10/09/2005 issued in this connection are allowed to continue the receipt of such number of increments, on personal to the holder basis.
 - iii. The employees who have been receiving 03 increments in recognition of a degree as at the effective date of this circular, i.e. 01st May 2016 should be granted 04 increments from that date.

- iv. If any employee who has been in receipt of 02 increments in recognition of a diploma obtains a degree, he/she should be granted a total of 04 increments by giving additional 02 increments, with effect from the date of receipt of such degree.
- 5. Provisions of this Circular is effective from 01st May 2016 and following Commission Circulars / Letters issued in relevant to the above are revoked with the implementation of this circular, subject to above 4(ii).
