Revision of Fees for Translations, Interpretations and Typing

Your attention is drawn to Para. 03 of Public Administration Circular 12/2003 (III) dated 22.08.2016 issued on the above matter.

02. The fees mentioned in 03 (a) 1 and (b) of the above Circular shall be revised in the following manner.

(a) Translation Fees

I. A fee of Rs. 2.50 shall be paid per word translated irrespective of the category of the document.

(b) Fees for Interpretation

To grant the allowance paid for the first hour as a specific allowance for interpretation, for every additional hour.
