MINIMUM REQUIREMENTS FOR ADMISSIONS

Candidates who are satisfied the minimum requirements at the G.C.E. (A/L) Examination held in 2019 for the University Admissions (Refer the section- 1.2 of the UGC Hand Book 2019/2020, Page- 12) and possess at least a credit pass (C) in the selected subject and a simple pass (S) in the other two subjects.

MEDIUM OF THE APTITUDE/ PRACTICAL EXAMINATION

The Aptitude/ Practical Examination will be conducted only in the Tamil Medium. (Refer the section- 2.2.1 of the UGC Hand Book 2019/2020, Page- 43)

SUBMISSION OF APPLICATIONS

Applicants should fill and submit the application form appended below through online. Further, applicants should send all the scanned documents mentioned in section – 6 of application form through online **on or before 30.06.2020** along with duly filled online application form. After completion of online application procedure, the duly filled application form should be printed and signed by the Applicants. Further, candidates should submit all the documents as stated in section 6 of application form along with printed and signed application form to **Senior Assistant Registrar/ Examinations & Admissions, Swami Vipulananda Institute of Aesthetic Studies, Eastern University, Sri Lanka** on the day of Aptitude/Practical examination.

Instruction for Section 6 (1) for Application Form

Application should accompany with a paying-in-voucher as proof of payment made for Rs.300/- as Examination fee obtained from any branch of the People's Bank drawn in favour of the **Senior Assistant Bursar, Swami Vipulananda Institute of Aesthetic Studies, Eastern University, Sri Lanka** A/C. Instruction for Section 6 (2 & 3) for Application Form

The certified copies of the G.C.E. (O/L) and G.C.E. (A/L) certificates should be attached along with the application. All copies of the certificates should be certified by the Principal of the School or Justice of Peace or Grama Niladhari. Original certificates should not be sent.

Instruction for Section 6 (5) for Application Form

If any discrepancy exists between the names indicated in the application and the names in the certificate/s, candidates should submit an affidavit attesting that they relate to one and the same person.

The date of the Examination would be informed in writing to each candidate who have satisfied the admission requirements.

The applications of those who do not possess the minimum admission requirements for the university admissions or applications which do not accompany with the paying-in-voucher or certified photo copies of certificates and applications received later then the closing date will be rejected.
