## **Annual Allocation 2019**

# HEAD No. 214 - University Grants Commission (UGC)

The Budget Estimates - 2019 have been prepared in consultation with the Universities/HEIs based on the policy guideline of the Sustainable Development Goals - Quality Education by 2030 and submitted to the Department of National Budget (NBD).

Accordingly, NBD recommended the Capital Block Grant (CBG) and Recurrent Block Grant (RBG) for the year 2019 and tabled in Parliament of Sri Lanka with the National Budget 2019.

The allocation given under the Vote on Account - 2019 have also been included in the annual allocation 2019 and it should not be considered as a separate allocation for the period of January - April 2019.

## 1. Preparation of Annual Budget

The Budget - 2019 mainly focuses to achieve sustainable development goals (SDGs) by - 2030. The SDG no 04 - Quality Education is directly linked with the universities /HEIs. Accordingly, four major policy areas proposed to be financed by the Budget - 2019

- Access to Higher Education
- Quality and relevance of Higher Education
- Sufficiency in Management Systems
- Research, innovation and knowledge transferring

The Universities/HEIs are requested to prepare their annual budget 2019 to address the above policy areas. The specimen guidelines for the preparation of budget estimates are given in Format I - XII.

### 2. Capital Block Grant (CBG)

CBG has been allocated to the Universities/HEIs considering the progress of utilization of funds and Public Investment Programme on construction projects. The universities/HEIs are requested to allocate funds for capital projects within the annual budget approved by the Council of the universities/Board of Management of the HEIs.

#### a) Construction Projects

Universities/HEIs are requested to allocate funds for the on-going construction projects on priority basis before the commencement of new projects. New construction projects should not be commenced during 2019 without sufficient allocations are provided in annual budget.

#### b) Other Development Projects

Universities/HEIs are requested to allocate funds for the Rehabilitation and Improvements of Fixed Assets, Acquisition of Fixed Assets, Human Capital Development and Research and Development projects on priority basis and provide sufficient allocations in annual budget.

### c) Empower differently able people

The Cabinet of Ministers has already directed to implement the Sri Lanka National Action Plan on disability which has been prepared based on national policy on disability. Accordingly, universities/HEIs are requested to allocate funds to facilitate differently able students and achieve outcomes of the national action plan on disability. The extract of the action plan on disability related to the higher education is given in Annexure - III.

- d) Acquisition of Lands and Vehicles Funds for the purchase of Lands and Vehicles should not be allocated by the CBG. The Universities/HEIs are required to follow the prevailing circular provisions for the procurement of Lands and vehicles.
- e) Postgraduate/Doctoral programs
  Postgraduate/Doctoral programs of university staff are financed by the UGC/NCAS
  and Universities/HEIs may not allocate funds from their CBG for this purpose.
  Postgraduate programs conducted by the universities/HEIs are proposed to finance through the generated income of postgraduate projects.

# 3. Continuation of Budget Proposal 2016-2018

UGC allocate funds only for the continuation of the projects implemented by budget proposals 2016-2018. Release of funds during the year will be considered by the UGC based on the performance of respective projects.

- a) Establishment of Technology Faculties in Universities Rs.3100Mn
- b) Accommodation facilities to Faculty staff of the universities -Rs.50Mn
- c) Establishment of Faculty of Medicine Wayamba University of Sri Lanka -Rs.600Mn
- d) Encourage accreditation with professional bodies of international repute Rs.10Mn
- e) Support the University of Colombo for new initiatives undertaken by the Department of Statistics Rs.200Mn
- f) Strengthening state of the art library facility and an IT Centre at the Vavuniya Campus
   Rs.150Mn

#### 4. Budget Proposal -2019

Hon Minister of Finance proposed following budget proposals to execute in respect of Higher Education. Circular instructions will be issued by the UGC for the implementation of the budget proposals with the consultation of Ministry of Higher Education.

#### 5. Asian Development Bank Funded Projects

The Technology Faculties of Rajarata University of Sri Lanka, Sabaragamuwa University of Sri Lanka, University of Kelaniya and Engineering Faculty of University of Sri Jayewardenepura are financed by the Asian Development Bank. The respective universities are advised to communicate with MoHE through UGC in respect of the implementation of projects.

# 6. Recurrent Expenditure Block Grant (RBG)

Recurrent Expenditure Block Grant for the year 2019 has been allocated by the NBD based on the estimates submitted by the Universities/HEIs. The recurrent budget estimates submitted by the UGC is based on the funding formula as given below.

RECURRENT GRANTS = Modified Cost per Student (MCPS) X Student Enrolment (SE)

Modified Cost per Student (MCPS) is computed considering following policy factors;

- Annual salary increments on actual cadre
- Inflation on other recurrent cost
- Capacity expansion on other recurrent cost
- Funding Ratio

# 7. Funding for Student Bursaries and Mahapola – Treasury Contribution

Universities are requested to follow the instructions given in Commission Circular No.02/2019 dated 29<sup>th</sup> January 2019 on "Payment of Mahapola Scholarships and Commission Circular 03/2019 dated 29<sup>th</sup> January 2019 on "Bursary scheme and payment of bursaries.

#### 8. Funds for Postgraduate Institutes

Postgraduate institutes are advised to finance their budget by the generated income. Capital Funds are allocated based on the Public Investment Programme approved by the UGC. RBG for the Postgraduate Institute are allocated only to finance their part of the recurrent expenditure as approved by the UGC.

# 9. The Master Procurement Plan and The Detailed Procurement Plan

Universities/HEIs are required to prepare the Master Procurement Plan and the detailed Procurement Plan as per the specimen formats given in the Procurement Manual - 2006. The Master Procurement Plan should be submitted with the annual budget 2019.

#### 10. Annual Action Plan

Universities/HEIs are required to prepare an Action Plan for the year 2019 as per the Public Finance Circular No. 01/2014 dated 17<sup>th</sup> February 2014 and should be submitted with the budget 2019.

#### 11. General Guidelines

- a) In terms of section 8 (2) (b) of the Finance Act. No. 38 of 1971 the approval of the Hon Minister in charge of the subject of finance and the concurrence of the Line Minister should be obtained before incurring capital expenditure in excess of Rs.500,000/-. Therefore Universities/HEIS are requested to submit their capital expenditure program to the UGC in order to obtain approval of the Hon. Minister of Finance in this regard.
- b) Please e-mail (finance@ugc.ac.lk) a soft copy of the Budget prepared as per Format-I -XII with Master Procurement Plan for each development project for the year 2019 on or before 10<sup>th</sup> April 2019.
- c) You are requested to submit hard copy of the budget on or before 12<sup>th</sup> April 2019 with a copy to the Director General, Department of National Budget, General Treasury.
- d) Do not change the standard formats by the Universities/HEIs for whatever reason.
