Annual Allocation - 2021

HEAD No. 214 - University Grants Commission (UGC)

The Budget Estimates - 2021 have been prepared in consultation with the Universities/HEIs and submitted to the Department of National Budget (NBD).

Accordingly, NBD recommended the Capital Block Grant (CBG) and Recurrent Block Grant (RBG) for the year 2021 and approved by the Parliament of Sri Lanka on 10th December 2020.

The University wise allocation - 2021 is given in Recurrent Grants (Annex -1) and Capital Grants (Annex-II)

1. Preparation of Annual Budget

The National Budget Department allocate funds to achieve the Higher Education policy guidelines of the National Policy Framework Vistas of Prosperity and Splendour. Accordingly universities/HEIs are requested to prepare the Annual Action Plan of the University as per approved allocation for the year 2021.

The specific guidelines for the preparation of budget - 2021 and specimen Formats I - XI are given in this circular.

2. Capital Block Grant (CBG)

CBG has been allocated to the Universities/HEIs considering the progress of utilization of funds and Public Investment Programme on construction projects. The universities/HEIs are requested to allocate funds for capital projects within the annual budget approved by the Council of the universities/Board of Management of the HEIs. Additional Allocations will not be considered by the National Budget Department for the year 2021.

a) Construction Projects

Universities/HEIs are requested to allocate funds for the on-going construction projects on priority basis before the commencement of new projects. New construction projects should not be commenced during 2021 without sufficient allocations are provided by the annual budget.

b) Other Development Projects

Universities/HEIs are requested to allocate funds for the Rehabilitation and Improvements of Fixed Assets, Acquisition of Fixed Assets, Human Capital Development and Research and Development projects on priority basis subject to the annual budgetary ceiling.

c) Postgraduate/Doctoral programs

Postgraduate/Doctoral programs of university Academic Staff are financed by the UGC/NCAS on competitive basis subject to the availability of funds. However, UGC does not have any objection for allocating funds for this purpose if other capital activities of the university could be managed within the allocated CBG.

3. Continuation of Budget Proposals 2016/2017

UGC allocate funds only for the continuation of the projects implemented by budget proposals 2016/2017. Release of funds during the year will be considered by the UGC based on the performance of the following projects.

- a) Establishment of Technology Faculties in Universities Rs. 2,000Mn
- b) Accommodation facilities to Faculty staff of the universities Rs. 25Mn
- c) Establishment of Faculty of Medicine Wayamba University of Sri Lanka –
 Rs. 150Mn
- d) Support the University of Colombo for new initiatives undertaken by the Department of Statistics Rs.50 Mn
- e) Strengthening state of the Art library facility and IT Centre at the Vavuniya Campus Rs.25 Mn
- f) Encourage accreditation with professional bodies of international repute–UGC. Rs. 50Mn

4. Foreign Funded/MoE Funded Projects

In addition to the CBG allocated under the Head No 214 -UGC, following projects have been financed by the Ministry of Education in the year 2021.

5. Recurrent Expenditure Block Grant (RBG)

Recurrent Expenditure Block Grant for the year 2021 has been allocated by the NBD based on the estimates submitted by the Universities/HEIs.

6. Funding for Student Bursaries and Mahapola - Treasury Contribution

Payment of student Bursaries and Mahapola Scholarships shall be made as per the instruction given in the Commission Circular No.02/2019 and 03/2019.

7. Funds for the Postgraduate Institutes

Postgraduate Institutes are advised to finance their budget by the generated income. Capital Funds are allocated based on Public Investment Programme recommended by the Capital Projects Monitoring Committee and approved by the UGC.

RBG for the Postgraduate Institutes are considered and allocated only to manage their permanent cadre positions as approved by the UGC.

8. The Master Procurement Plan and the Detailed Procurement Plan

Universities/HEIs are required to prepare the Master Procurement Plan and detailed Procurement Plan as per the instructions given in the Public Finance Circular No.02/2020 dated 28.08.2020 and the Guideline 13 of the Public Finance Circular No.02/2020. The Master Procurement Plan should be submitted with the Annual Budget - 2021.

9. Annual Action Plan

Universities/HEIs are required to prepare an Action Plan for the year 2021 as per the Public Finance Circular No. 02/2020 dated 28.08.2020 and required to be submitted with the budget 2021.

10. General Guidelines

a) In terms of section 8 (2) (b) of the Finance Act. No. 38 of 1971 the approval of the Hon Minister in charge of the subject of finance and the concurrence of the Line Minister should be obtained before incurring capital expenditure in excess of Rs.500,000/-. Therefore Universities/HEIs are requested to submit their capital

expenditure program to the UGC in order to obtain approval of the Hon. Minister of Finance in this regard.

- b) Please e-mail (<u>budget@ugc.ac.lk</u>) a <u>soft copy of the Budget prepared as per Format-I to XI, Master Procurement Plan and Action Plan for the year 2021 on or before 21st December 2020 with a copy to National Budget Department.</u>
