## Appointment of Internal Auditors to Campuses/Institutes

Your attention is invited to the letter sent by the Director General, Department of Management Audit, General Treasury and the subsequent letter No. UGC/S/PA/111 dated 28.07.2020 regarding the above matter.

The Commission at its 1054<sup>th</sup> meeting held on 06.05.2021 having noted that most Campuses/Institutes have not taken action to appoint an Internal Auditor to their organization decided to recommend following procedure to appoint an Internal Auditor.

- i. Campuses/Institutes should refer above provisions to their Audit Committee and decide the required cadre positions for them to establish Internal Audit Units (IUAs) in their Campuses/Institutes and make necessary recommendations to the Council/Board of Management for approval.
- ii. The required cadre provisions with the approval of the Council/Board of Management should be submitted to the General Treasury through the Chairman/UGC for the approval.
- iii. The Internal Audit Circular Letter 01/2019 dated 10.01.2019 and the Internal Audit Circular Letter 03/2019 dated 26.07.2019 issued entrusting the audit works of Campuses/Institutes to the Internal Audit Departments of Universities of which such Campuses/Institutes are attached would automatically be rescinded when Internal Audit Unit is established by the respective Campus/Institute.
