AMENDMENTS TO THE SCHEMES OF RECRUITMENT FOR THE POSTS OF SENIOR LECTURER GRADE II AND GRADE I – (MEDICAL/DENTAL)

Your reference is invited to the Posts No. 4, 5 and 8 of Commission Circular No. 721 of 21.11.1997 and Commission Circular No. 08/2016 of 14.06.2016 as amended by Commission Circulars No. 08/2016(i) of 17.11.2016, 08/2016(ii) of 04.09.2017 and 08/2016(iii) of 02.06.2021, related to Schemes of Recruitment of the Academic Staff.

- 2. The Commission, at its 1073rd and 1076th meetings held on 24.02.2022 and 07.04.2022, respectively, decided that the Medical/Dental category academic staff who opt for Masters degree other than MD should be considered under Paragraph 3(b) (ii) of the Commission Circular No. 08/2016, which is applicable for the Faculties of Science/Applied Science/Engineering/Agriculture/Technology, since Faculties of Medicine and Dental Sciences are also considered as science-based faculties.
- 3. Accordingly, Qualifications No. 2 (i) of Post No. 4, 1 (i) of Post No. 5 and 2 (i) of Post No. 8, of Commission Circular No. 721 shall be:
 - (a) A Doctoral Degree in the relevant field

OR

(b) MD/MS and Board Certification by the Postgraduate Institute of Medicine (PGIM) where required or its equivalent

OR

- (c) A Masters Degree in the relevant field with full time research of at least 24 months duration
- 4. The provisions of this circular will come into effect from 05.05.2022, without prejudice to any action taken so far.
- 5. Please take action accordingly, and bring this to the notice of the academic staff concerned.
