## **PAYMENT OF RESEARCH ALLOWANCE**

Your attention is invited to Establishments Circular Letter No. 05/2014 of 25.03.2014, Higher Education Circulars No. 01/2011 of 20.04.2011 and 01/2011(I) of 12.05.2011 as restored by the Establishments Circular Letter No. 05/2014(i) of 28.05.2014, Establishments Circular Letter No. 05/2014(ii) of 30.05.2014 and Commission Circular No. 1000 of 08.01.2013 with regard to the payment of Research Allowance in the university system.

2. The Commission at its 1076<sup>th</sup> and 1079<sup>th</sup> meetings held on 07.04.2022 and 09.06.2022, respectively, decided to inform the Higher Educational Institutions/Institutes that the following category may be considered by the Council based on the recommendation of the Research Management Committee and the Senate of the respective University, in addition to the existing eligibility requirements to be fulfilled under Section No. 03: 'Methodology' of Higher Education Circular No. 01/2011 and other relevant circular provisions to pay Research Allowance to provide incentives for innovation & commercialization of research by the eligible staff;

"Submission of a copy of a signed license agreement for commercialization of an invention with the private sector where the contribution of the eligible staff can be proved through the Invention Disclosure Form submitted to the University Business Linkages (UBL) in the  $01^{\rm st}$  year and submission of evidence to show the product in the market or service being used commercially in the  $2^{\rm nd}$  and  $3^{\rm rd}$  years."

3. The above provision is effective from 09.06.2022.
