The UGC, which is the apex body of the University System in Sri Lanka is looking for a competent, dynamic, and experienced person to serve as the Director, Centre for Gender Equity/Equality (CGEE) of the UGC on contract basis for a period of two years.

Qualifications:

Academic Staff member in the University System holding the post of Senior Professor or Professor, with a Ph. D.

Note:

- > The Centre for Gender Equity/Equality (CGEE) is the implementation arm of the UGC Standing Committee on Gender Equity/Equality which is the standard setter, policy maker, regulator and arbitrator of UGC policy on gender equity/ equality in Sri Lankan state Universities. The CGEE is headed by a Director and administrative staff who reports back to the Standing Committee.
- Provide leadership to assist the Standing Committee on Gender Equity / Equality /UGC to develop UGC policy, facilitation of the establishment/ development of appropriate structures/systems on Gender Equity and Equality in Sri Lankan Universities and HEIs, in monitoring and supporting Universities and HEIs for implementing of UGC policy on Gender Equity and Equality.
- ➤ Facilitate the review of UGC policies & programs from a perspectives of Gender Equity / Equality, in strengthening grievance redress procedures related to sexual and gender-based violence in Sri Lankan Universities.
- > To house and implement a mechanism of redress for sexual and gender-based violence in universities under the purview of University Grants Commission.
- > To provide expertise on Gender Equity / Equality to develop curricula and research, and contribute other gender-related inputs to the University Community.
- > To conduct training for university communities staff, students on Gender Equity/ Equality.
- ➤ Providing overall leadership, management accountability and directing relevant staff in delivering achieving/objectives of the CGEE/UGC.
- ➤ Leading the CGEE / UGC by providing required expertise and providing directives on issues related to gender, equity, diversity, inclusion, human rights, gender based violence for policy making and implementation.
- > Sustain ongoing projects/ programmes/ of the CGEE/UGC and successful implementation of planned activities as per the Action Plans, Strategic Plan of the UGC.

- > Excellent organizational skills with the ability to work under pressure and simultaneous performance of tasks.
- > Co-operate and network (liaise) with multidisciplinary, cross cultural teams in an inclusive manner.
- Maintaining positive relationships and meet the work standards expect by the Standing Committee on Gender Equity/ Equality/ UGC, donor agencies and the University Community.
- > Clearly communicating gender justice, rationale and concepts to internal and external audiences.
- ➤ Identifying representation, gender equity/ equality/ inclusivity gaps in the university system and planning activities/ initiatives to address those gaps.

Selection will be made in the order of merit which will be decided on the marks of a structured interview.
