### PAYMENT OF AN INTERIM ALLOWANCE TO NON ACADEMIC NON ADMINISTRATIVE STAFF

Your kind attention is invited to Commission Circular No. 850 of 22<sup>nd</sup> October, 2004 on payment of an allowance as per agreement signed between the Cabinet Sub-Committee and the Inter University Trade Unions Joint Committee on 23<sup>rd</sup> September, 2004.

2. (a) The Cabinet of Ministers at the meeting held on 10<sup>th</sup> February, 2005 granted approval to pay an allowance based on the salary structure recommended by the Sri Lanka Institute of Development Administration (SLIDA) to the employees who are on the salary codes of A-04(a), A-04 (c), A-04(d) and A-05 to A-15 until a new salary structure is implemented based on recommendation of the National Council for Administration.
- (b) The General Treasury by the letter dated 16<sup>th</sup> February, 2005 has informed that they have no objection to payment of an interim allowance to the Non Academic Non Administrative Staff in the University System.
3. Accordingly, the amount payable per month to permanent employees who are presently holding the posts denoted by salary codes of A-04(a), A-04(c), A-04(d) and from A-05 to A-15 with effect from 01<sup>st</sup> January, 2005 are indicated below:-
