REVISION OF PAYMENT OF EQUALIZATION ALLOWANCE TO MEDICALLY AND DENTALLY QUALIFIED TEACHERS AND MEDICAL OFFICERS/ DENTAL SURGEONS IN THE HEALTH CENTRES BASED ON GENERAL CIRCULAR NO. 01-13/2008(i) OF 15.05.2008 ISSUED BY THE MINISTRY OF HEALTHCARE AND NUTRITION

Your kind attention is drawn to Commission Circular Nos. 886 and 899 and dated 16.01.2007 and 15.09.2008 respectively, on payment of Equalization Allowance to Medically and Dentally qualified teachers.

- The Director General, Department of Management Services by his letter No.DMS/EI/54/3/313/2 dated 18th June 2010 has granted approval to revise payment of Equalization Allowance from Rs.5000/- to Rs. 10000/- based on the Health Ministry General Circular No. 01-13/2008(i) of 15.05.2008 to Medically and Dentally qualified teachers within the funds available for the year 2010.
- Therefore, the Higher Educational Institutions are requested to make arrangements to pay Equalization Allowance to Medically and Dentally qualified teachers, University Medical officers and Dental Surgeons in the University System w.e.f. 01.01.2010 within the funds available for the year 2010 in the Higher Educational Institutions concerned.
