REVISED SCHEMES OF RECRUITMENT FOR THE POSTS CARRYING SALARY CODE OF U-EX I (IV) AND ABOVE COMMISSION CIRCULAR NO. 922 OF 23RD JUNE 2010.

Your attention is invited to Commission Circular No. 922 of 23rd June 2010 on the above subject.

The University Grants Commission at its 808th Meeting held on 15th July 2010 has decided to grant a **grace period of 3 years** reckoned from 1 July 2010, (the date on which Commission Circular No. 922 came into force) for those Officers in the Executive Grades (i.e. posts carrying salary scales denoted by U-EX1(IV) and above) who were in such grades as at 30.06.2010 to apply for appointment/promotion to higher posts/grades at the Middle/Senior Executive Level in terms of the provisions of the Schemes of Recruitment which were in force prior to issuing the Commission Circular No.922.

The Higher Educational Institutions are requested that an option be given to such employees to apply for the appointments/promotions either under the old Schemes of Recruitment which existed prior to implementation of Commission Circular No.922 or New Schemes of Recruitment stipulated in Commission Circular No.922.

It was also decided to rescind Commission Circular Nos. 566, 657 and 701 of 18.03.1993, 19.12.1995 and 11.02.1997 respectively with effect from 01 July 2010 as these circulars are no longer applicable.

The terms and conditions stipulated in Commission Circular No.922 of 23rd June 2010 will remain unchanged subject to the above amendments.

The provisions of this circular are effective from 01st July 2010 and the grace period will be granted upto 30th June 2013.
