Payment of a Special Advance to Public Officers who were affected by Floods and Earth slips occurred in January 2011

A decision has been taken to pay an interest free special advance to public officers who are residing in Ampara, Batticalo, Trincomalee, Polonnaruwa, Anuradhapura and Kandy districts and affected by floods and earth slips occurred in January 2011.

- 02. The amount of this special loan should be equivalent to three months consolidated salary, excluding allowances, of the officer and should be recovered in ten equal monthly installments.
- 03. This loan is exempted from the total monthly deduction limits of deductibles from the salary mentioned in Section 03 Chapter XXIV of the Establishment Code.
- 04. If the officers who are entitled under this circular, have obtained a special advance as per Public Administration Circular 10/2010 dated 20.08.2010, action should be taken separately to recover such amount.
