Attachment of Trainees to Public Institutions for Practical Training

Your attention is hereby drawn to the Public Administration Circular No 12/2000 (I) dated 03.08.2006 which was issued revising para 5 of the Public Administration Circular 12/2000 dated 19.07.2000

- 02. Para 5 which was revised by the aforementioned circular shall be revised again as mentioned below.
 - "05. A daily allowance of Rs.300/- for a trainee may be paid only if necessary provisions are available and no other allowance or remuneration should be paid." $^{\prime\prime}$
- 03. Further, all the other practical trainings should be limited to a period of six months, except the practical training in technical category mentioned in para 06 of Public Administration Circular 12/2000. This revision shall come in to effect from $1\,\mathrm{st}$ June 2011
- 04. This circular is issued with the concurrence of the General Treasury.
