**THE UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 27 (1) (a) read with Section 21 and Section 139**

BY virtue of the powers vested in me by Section 27 (1) (a) of the Universities Act, No. 16 of 1978, I, A. D. Susil Premajayanth, Minister of Higher Education, on the recommendation of the University Grants Commission, do by this order, amend the Schedule to the Order published in *Gazette Extraordinary* No. 1518/15 of October 09, 2007 (as amended from time to time) which specifies the Faculties and Departments of the University of Jaffna, Sri Lanka which is deemed, by virtue of the provisions of Section 139 of the aforesaid Act, to be a University established under Section 21 of the said Act, as follows:-
