Government Notifications

L.D.-B. 21/78 (XV) (B)

THE UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 27(1) read with Section 21 and Section 139

BY virtue of the powers vested in me by Section 27(1) of the Universities Act, No. 16 of 1978, I, A. D. Susil Premajayanth, Minister of Education, on the recommendation of the University Grants Commission, do by this Order, amend the Schedule to the Order Published in *Gazette Extraordinary* No. 1518/15 of October 9, 2007 (as amended from time to time) which specifies the Faculties and Departments of the University of Jaffna, Sri Lanka, which is deemed, by virtue of the provisions of Section 139 of the aforesaid Act, to be a University established under Section 21 of the said Act, as follows:-

- (1) by the repeal of the item “Sri Ponnambalam Ramanathan Faculty of Performing and Visual Arts” appearing in Column I of the Schedule (specified in the order published in *Gazette Extraordinary* No. 2293/22 of August 16, 2022) and the substitution therefore of the following -

“Sir Ponnambalam Ramanathan Faculty of Visual and Performing Arts”

- (2) by the addition immediately after the item ‘Sri Ponnambalam Ramanathan Faculty of Performing and Visual Arts’ appearing in Column I of the schedule and its corresponding entries in Column II thereof of the following new faculty and Departments of Study -

“Faculty of Siddha Medicine

- 1) Department of Moolathaththuvam,
- 2) Department of Gunapadam,
- 3) Department of Noi Naadal Chikitchai,
- 4) Department of Kuzhanthai and Mahalir Maruththuvam,
- 5) Department of Sirorogam and Aruvai Maruthuvam,
- 6) Department of Samooganala Maruthuvam,
- 7) Department of Manitha Uyiriyal
- 8) Department of Nanjiyal and Paramparai Maruthuvam;

- (3) Every reference to the “Sri Ponnambalam Ramanathan Faculty of Performing and Visual Arts” in any notice, notification, contract, communication, agreement, Order, form or other document shall be read and construed as a reference to the “Sir Ponnambalam Ramanathan Faculty of Visual and Performing Arts”.
- (4) Any power, duty and function exercised, discharged and performed by the said “Sri Ponnambalam Ramanathan Faculty of Performing and Visual Arts” prior to the date of coming in to effect of this Order in pursuance of any power conferred on it by the Order published in *Gazette Extraordinary* No. 2293/22 of August 16, 2022 shall be deemed for all purposes to have been validly exercised and performed by the “Sir Ponnambalam Ramanathan Faculty of Visual and Performing Arts”.
