ORDINANCE made by the University Grants Commission under Section 140 read with Section 18 of the Universities Act, No. 16 of 1978.

Ordinance

- 1. This Ordinance may be cited as the Postgraduate Institute of English (Amendment) Ordinance No. 3 of 2014 and shall come into force on 05.08.2014.
- 2. The Postgraduate Institute of English Ordinance, No. 4 of 2005, published in Gazette Extraordinary No. 1417/12 of 31st October, 2005 is hereby amended as follows:—
 - (1) in paragraph 4 thereof-
 - (i) by the substitution for the word "Engish" in sub paragraph (c) of that paragraph, of the word "English";
 - (ii) by the substitution for the word "distintions" in sub paragraph (e) of that paragraph, of the word "distinctions";
 - (iii) by the substitution for the word "intitutions" in sub paragraph (f) of that paragraph, of the word "institutions"; and
 - (iv) by the substitution for the word "funtions" in sub paragraph (n) of that paragraph, of the word "functions";
