Ordinance

- 1. This Ordinance may be cited as the Postgraduate Institute of Medicine (Amendment) Ordinance, No. 3 of 2001 and shall come into force upon publication in the *Gazette*.
- 2. The Postgraduate Institute of Medicine Ordinance, No. 1 of 1980, published in the Gazette Extraordinary No. 83/7 of April 10, 1980 as last amended by the Postgraduate Institute of Medicine (Amendment) Ordinance No. 4 of 2000 published in Gazette Extraordinary No. 1155/20 of October 27, 2000 is hereby further amended as follows:—
 - (1) In Paragraph 13 thereof, by the insertion of the following sub-paragraph immediately after the paragraph (r)
 - "(s) Venereology."
 - (2) In paragraph 14 thereof
 - (i) by the repeal of Sub-paragraph (2) (c) (iii) of that Paragraph and the substitution of the following therefor:
 - "(iii) in respect of the speciality of Clinical Oncology and Venereology, nine representatives from the training centres referred to in Sub-paragraph (2)(c)(i) of that Paragraph of whom at least three shall be from the following main training centres
 - (a) the Cancer Institute of Maharagama; and
 - (b) Central STD Clinic.";

 - (ii) by the repeal of Sub-paragraph (3) of that Paragraph and the substitution of the following therefore :-
 - "(3) All such members of the Board of Study referred to in Sub-paragraphs (1) and (2) shall be trainers, except in the specialities of Family Medicine and General Practice and Venereology, a trainer shall be a person having three years experience after Board certification of eligibility for privileges of Board certification, or in the case of para clinical disciplines, five years experience after Doctor of Medicine (M.D.) or equivalent qualifications in the relevant field, or three years experience as a trainer in the relevant field;

Provided however, the relevant field in Venereology is Community Medicine. A trainer in Venereology is a person recognized as a specialist in Venereology by the Ministry of Health or a specialist in another discipline working in an approved training centre:

Provided however, that the representatives from the training centres referred to in Sub-paragraph (1)(d) and Sub-paragraph (2)(c), shall be selected by the trainers of the Ministry of Health of the relevant speciality, in the training centres as the case may be. The Director-General of Health Services or the Director of the Sri Jayawardenapura Hospital shall submit names of such persons who have been selected to the Director."

(3) In paragraph 25 thereof, by the repeal of the definition "Speciality in Medicine" and the substitution therefor, of the following definition:-

"Speciality in Medicine" means Anesthesiology, Community Medicine, Family Medicine and General Practice, Medicine, Obstetrics and Gynaecology, Opthalmology, Pathology, Paediatrics, Psychiatry, Radiology, Surgery, Forensic Medicine, Microbiology, Otolaryngology, Radiotherapy, Oncology, Dental Surgery, Medical Administration, Health Sciences, Dermatology and Venereology or any other speciality approved by the Commission upon the recommendation of the Institute and the University."
